INDIVIDUAL BOOKINGS

All bookings need to be confirmed within 24 hours of the provisional booking being made

PAYMENT TERMS – DIRECT/PRIVATE BOOKINGS

A reservation will remain provisional until it is confirmed with a 50% deposit.

Full payment is required 30 days before arrival.

All bank deposits are to be received free of any bank charges or commissions.

CANCELLATION POLICY – DIRECT/PRIVATE BOOKINGS

More than 60 days prior to arrival	:	Full amount refundable
Less than 59 days but more than 30 days	:	25% of full amount payable
Less than 29 days but more than 14 days	:	50% of full amount payable
Less than 13 days prior to arrival	:	100% of full amount payable

Written confirmation required for all cancellations (e-mail or facsimile)

GROUP BOOKINGS

Any party reserving 3 chalets or more is considered a group

PAYMENT TERMS – PRIVATE GROUPS (INCLUSIVE OF WEDDINGS)

50% deposit is required to secure a group/wedding reservation.

100% payment is required 60 days before arrival.

All bank deposits are to be received free of any bank charges or commissions.

CANCELLATION POLICY – PRIVATE GROUPS (INCLUSIVE OF WEDDINGS)

More than 120 days	:	50% of full amount payable
Less than 60 days but more than 30 days	:	75% of full amount payable
Less than 29 days prior to arrival	:	100% of full amount payable

Written confirmation required for all cancellations (e-mail or facsimile)

FIT INDIVIDUAL BOOKINGS

Provisional bookings will be held for 14 days after which they will have to be confirmed or released.

Provisional bookings within 60 days of arrival will need to be confirmed or released within 48 hours.
